### RULES & CRITERIA FOR FOREIGN MEDICAL GRADUATES FOR CRMI REGULATION 2021

1. The Foreign Medical Graduates who are willing to start the internship in State of Jharkhand, are required to fill up the online form to be considered for Internship Training and the application are accepted only on total no. of seats available in Medical Colleges in Jharkhand. For filling up the online form details are as follows:

Application Fee:	Rs. 10,100/- (Non – Refundable)		

2. Jharkhand State Medical Council will scrutinize all the applications and shall prepare two Merit lists considering CRMI Regulations 2021 (based on criteria mentioned below) and the same will be published on the website of Jharkhand State Medical Council.
3. The selected candidates have to join the internship programmed immediately but not later than 20 days from the date on which final list is uploaded on official website of Jharkhand State Medical Council. If candidate is not able to join the allotted medical college/institution within 20 days allotted seat will be rejected.
4. Jharkhand State Medical Council has the right to reject any application in case it doesn't fulfill the criteria or the applications received are more than the seats available in medical colleges in Jharkhand.
5. If the candidates withdraw the application for any reason then the fees will not be refunded.

### CRITERIA FOR PREPARING MERIT LIST

Two separate lists will be published according to following criteria:

Merit List 1 (ML1): Candidates who are resident of Jharkhand (Passport as Address proof/Residential Cert. issued by S.D.O).

Merit List 2 (ML2): Candidates who are resident of other states (if seats remain vacant after the allotment of seats to candidates who are resident of Jharkhand).



Merit list will be prepared based on N.B.E.M.S. score of Screening Test Result obtained by the candidate and in case more than one candidate with same score, merit will be determined on the basis of following criteria:-

- a. Candidate who has secured higher percentage in subjects of Physics, Chemistry, Biology (PCB) marks in (10+2) examinations.
- b. Candidates who has secured higher percentage in subject of Biology marks in 10+2 examinations
- c. Two merit lists will be made for seat allotment to the candidates. First merit list will be for the candidate domicile of Jharkhand & second merit list will be for the candidate domicile out of Jharkhand.

The amount of stipend to be paid to the interns is to be decided/fixed by the appropriate authority and is solely at the discretion of the concerned authorities under which the medical college/institute is located and Jharkhand State Medical Council does not bear any liability in this regard.
